# 1. Background Information

#### 1.1 INTECMED

INTECMED project aims at facing common challenges of the areas involved in the project, all characterized by two phenomena: generalized economic slowdown and serious job deficit. In the mid-term, the project expects to set up a stable decision-makers group to define an innovation strategy at the local level able to coordinate all actions of different players. The pilot project mentorship programmes will improve the competencies and capacities to commercialize research results of at least 48 entrepreneurs/researchers.
