Sorting of fresh vegetables (tomato, eggplant, pepper, artichoke, cucumbers, carrots, courgettes, garlic, onion, green beans, potatoes and sweet potatoes) and fresh fruits (lime, orange, mango, pomegranate, grapes) packed in polyethylene or carton boxes. Mixing, CO2 treatment (outsourced), and packing of dry herbal tea in filter bags. Packing of dried vegetables (e.g. onion, garlic), herbs (e.g. basil) and spices (e.g. black pepper, black seeds) in bulk laminated paper bags and glass jars. Extraction, filtration and packing of seed oils (e.g. black seed oil, peanut oil, jojoba oil, flax seed oil) in plastic or metal barrels. Extraction of fruit juice, filtration, pasteurization (e.g. orange, grapefruit, pomegranate) and packing in polyethylene bags and metallic drums.
